(SHAPES). **To activate this limited lifetime warranty, return of this completed warranty registration to SHAPES within 30 days after delivery.** This warranty is only valid to the original purchaser, and is not transferable to any other party.

This warranty only covers specific defects in material and workmanship of the product. SHAPES warranty covers its aluminum fence products against the paint cracking, peeling, chipping (Hardware not included). This warranty does not apply in marine, salty, or harsh environmental conditions. The warranty becomes invalid if the product is improperly installed, altered, misused, damaged caused by negligence, abuse, accident, damaged in transit, mishandling, exposure to corrosive elements or by acts of God. This warranty does not cover the appearance associated with normal weathering. Furthermore, it does not cover damage caused by oxidation caused by airborne chemicals or by air pollution. This warranty is void if the product is exposed to the application of paint, varnish, chemicals (including lawn care chemicals), or chemical cleaning agents not approved by SHAPES.
