Clubhouse Decking with SunShield and Korelite Technology 25-Year Limited Stain and Fade Resistant Warranty

Clubhouse Decking with SunShield and Korelite Technology is designed to resist fading, and while no material is fade-proof when exposed to years of UV exposure of the elements, Clubhouse Decking is warranted not to fade by more than 5 Delta E (Hunter) Units for a period of twenty five years pro-rated from the date of installation.

Stain Resistance Warranty Coverage

Clubhouse Decking with SunShield and Korelite Technology is designed to resist staining for a period of twenty five years when applied to a residential application. While no product is stain-proof, Clubhouse Decking does provide a high level of stain resistance to permanent stains resulting from spills of common food and beverage items including: wine, tea, coffee, fruit punch, soda, ketchup, mustard, salad oils, barbecue sauce and other food or beverage items that would typically be in use on a residential deck. When exposed to spills from these items the deck should be cleaned with mild soap and water no longer than one week after the spill has occurred. Materials not covered by the stain resistance warranty include but are not limited to abrasive compounds of acidic or basic pH, strong solvents, oil and water based paints or stains, acetone, methylethylketone, mineral spirits, petroleum ether, toluene, xylenes, methylene chloride, metallic rust or other abnormal contact from items not connected with a residential deck. Additional items not covered under the stain-resistant warranty include substances such as non-food and non-beverage exposures. Some examples include, but are not limited to, fungicides, bactericides, biocides, plant food, animal and human stains from fluid and waste.

Limitations of Coverage THIS LIMITED WARRANTY DOES NOT COVER:

(i) damages and defects resulting from the improper installation of Clubhouse Decking, including but not limited to, installation directly on top of or attached to a concrete slab, installation directly on the ground, installation on top of other decking, or any installation that does not provide for proper ventilation above, below and to the side, or lack of proper 1/8" side to side gapping between deck boards for drainage;

(ii) damages resulting from defective fasteners, sub-structures or other components; (iii) defects or damages caused by accident, fire, flood, lightning, hurricane, tornado, sandstorm,

earthquake or other acts of God, vandalism, misuse, abuse, harmful fumes, vapors or chemicals, settlement, structural shrinkage or distortion of the structure;

(iv) defects resulting from the subsequent modification(s) of Clubhouse Decking including the external modification of Clubhouse Decking (e.g. application of primers, paints or solvents to the Covered Product); (v) mold or mildew growth, fading (less than 5 Delta E Hunter Units) or chalking due to normal effects of environmental weathering;

(vi) exposure which is direct or indirect to heat which exceeds 250 degrees;

(vii) improper installation of the product which does not follow either local building codes and (or) Deceuninck's installation instructions for Clubhouse Decking & Cellular PVC Decking;

(viii) use of the product in non-residential deck applications;


(ix) surface damage as a result of using shovels or sharp edged tools to remove snow and ice on the surface of the deck;

(x) if the surface becomes punctured or damaged in any manner the twenty-five year stain and fade resistance warranty will be void. In addition if paint, stains or other coating materials are applied to the Clubhouse Decking this warranty is void.

Clubhouse Decking is an exclusive product line produced by Deceuninck North America, LLC (Deceuninck North America, LLC and the Clubhouse brand of products hereinafter collectively referred to as "Clubhouse") and all Clubhouse products have been manufactured to exacting standards to ensure their beauty will last for years. That's why all Clubhouse products ("Covered Products") are backed by our exclusive Limited Lifetime Warranty, which provides warranty protection for consumers subject to certain conditions and limitations, and a Twenty Five Year Limited Stain and Fade Resistant Warranty that warrants the fade and stain resistance of Clubhouse Decking manufactured by Deceuninck.

- If the Covered Products are defective, we will replace them.
- The Covered Products are covered for as long as the Original Retail Purchaser owns the Covered Products.
- This Warranty is for Clubhouse Decking only and only when installed on a single family residential application.
- Warranty applies to the original owner (purchaser) of Clubhouse Decking as long as they own and occupy the residence upon which Clubhouse Decking was applied.

How Do You Submit a Warranty Claim?

You must submit your claim in writing to Deceuninck within a reasonable period of time after the defect is discovered. To initiate a claim, you should contact our warranty services number at 1-877-563-4251 to receive a warranty claims packet. Receipt of a warranty claims packet does not constitute any commitment by Deceuninck that the claim has been accepted.

Claims Process & Remedy

Deceuninck shall have ninety (90) days to inspect the Covered Products. If Deceuninck determines the claim is valid in accordance with this Warranty, Deceuninck agrees at its sole discretion to either;

Provide to the Original Retail Purchaser who still owns and occupies the home on which the decking was installed with deck boards to repair or replace the defective deck boards. Replacement material will be provided in an amount equal to the prorated schedule listed below. Replacement product will be provided that is as close as possible to the original material installed but there is no warranty relative to an exact match relative to color or design.

Refund the percentage of the actual purchase price of the material only as listed on the Prorated Warranty Schedule if a.) The claimant is willing to accept a refund or b.) Deceuninck deems the repair is not commercially viable and/or cannot be made in a timely fashion.

It is the responsibility of the homeowner to have complied with the recommended deck care and maintenance procedures outlined in our installation manual and available on the Deceuninck web site www.deceuninck-americas.com. To qualify for coverage, you must have tried to clean the affected area by using the cleaning procedure available on the web site. If the affected area remains unsatisfactory after you have tried these cleaning procedures, then you must have the affected area of your deck professionally cleaned (cleaning performed by a company specializing in professional cleaning) at your expense. If the affected area remains unsatisfactory after the professional cleaning, you must contact Deceuninck Customer Service at 1-877-563-4251 or email us at Support@Deceuninck-info.com. It will be the claimant's responsibility to supply photographs depicting the claim. In no event shall Deceuninck be liable for labor, installation or reinstallation costs related to defective Products. Additionally, our obligation under this Warranty shall in no event exceed the purchase price of the originally installed Products found to be defective.

The Warranty Period shall not be extended by any such replacements but the replacement Product shall continue to be covered during the remainder of the original Warranty Period. Deceuninck reserves the right to discontinue production of any Covered Product. If a Covered Product has been discontinued or is for some other reason no longer available, Deceuninck reserves the right to substitute another product of comparable function and quality for such Covered Product. Deceuninck shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort, strict liability or otherwise. In any dispute over the performance of the Product, the purchaser shall have the burden of proof that the Product was installed and maintained in accordance with the Manufacturer's applicable instructions.

ANY REPAIR OF THE PRODUCTS UNDERTAKEN WITHOUT PRIOR WRITTEN AUTHORIZATION FROM DECEUNINCK WILL VOID THIS WARRANTY.

We frequently update our installation manuals with new and improved methods of application. You should discuss any product adjustments with the dealer, contractor or other party who performed the installation. These adjustments can best be made by the original dealer or installer since he or she is most familiar with your particular installation.

FAILURE TO FOLLOW THE RECOMMENDED INSTALLATION INSTRUCTIONS WILL VOID THE WARRANTY.

Clubhouse Decking with SunShield and Korelite Technology Limited Lifetime Warranty

Statement of Warranty

Subject to the terms, conditions and limitations set forth herein, Deceuninck warrants to the Original Retail Purchaser ("Purchaser") of Clubhouse Decking products ("Products") that the Covered Products are free from Covered Defects for the life of the original homeowner(s), as defined below.

"Deceuninck North America" or "Deceuninck" shall mean Deceuninck North America, LLC, whose principal business address is 351 North Garver Road, Monroe, Ohio 45050, USA.

"Original Retail Purchaser" is the initial purchaser of Covered Products manufactured by Deceuninck for resale as Clubhouse Products where such Products were purchased directly from an authorized Clubhouse Products dealer for use in the consumer's residential dwelling.

"Commercial Applications" shall be excluded from the Limited Lifetime Warranty AND Twenty Five Year Limited Stain and Fade Resistant Warranty which applies only to residential applications as set forth herein. For all other non-residential and commercial use purchasers otherwise qualifying as Original Retail Purchasers, this warranty will be limited to a period of twenty-five (25) years commencing on the date of installation and continuing as long as the Original Retail Purchaser remains in ownership of the structure. For all nonresidential structures, including commercial applications, this warranty is non-transferable.

"Covered Products" shall mean the Clubhouse Decking Products when used in accordance with the recommendations and specifications of Deceuninck. This warranty is for material only excluding any labor or installation costs and does not extend to fasteners or any accessory products not specifically manufactured by Deceuninck under Clubhouse Products brand.

"Covered Defects" shall mean manufacturing defects in material and/or workmanship of Clubhouse Covered Products resulting in material checking, splitting, splintering, rotting, pitting, blistering or suffering structural damage from termites or fungal decay under normal exposures and conditions.

"Warranty Period" shall apply to the Original Retail Purchaser, as long as they own and occupy the residential dwelling upon which the material was applied. Any claims under this Warranty are expressly limited, at the sole discretion of Deceuninck North America, to either (i) the original retail purchase price of the Covered Products, or (ii) provide to the Original Clubhouse Decking Purchaser non-defective replacements of Covered Products.

"Warranty Transfer" shall mean this Warranty may be transferred one (1) time within the first five (5) years following the date of installation. Upon transfer the term of the Warranty shall be 25 years from the date of installation. Warranty Transfer shall be limited to residential consumer Original Retail Purchasers only.
